Dear PJTN Board and Advisors,

Recently in a weekly strategy meeting, our team shared my calendar for the first quarter of 2022, and it is full of meetings in Florida, California and Tennessee. Following our internal review and evaluation in Q4 2021, we made a strategic decision to focus our work on areas with the greatest potential for impact. In addition to the obvious attempts to "hijack" our next generation of leadership in America through a corrupted educational model, PJTN shines a light behind the dark curtain to reveal the early roots of antisemitism that are being force-fed to our children in grades as early as pre-school. Unlike other organizations suited up for the battle, we are waging a war on antisemitism where it begins: in America's classrooms, grades K-12.

The Problem:

As the Biden era has brought radical change to our nation, we are witnessing a media/academia/government takeover determined to overthrow America's Judeo-Christian foundation. Their playbook borrows from Germany in the 1920s. Hitler wrote in Mein Kampf that "whoever has the youth has the future." Our "youth" are now indoctrinated with the new "woke" ideology - lies of 'white privilege,' Marxist Critical Race Theory (CRT), revisionist history, Holocaust revisionism and the antisemitic, racist Black Lives Matter (BLM) movement. Textbooks and instructional materials have become anti-American, anti-West, anti-Israel and anti-Judeo-Christian. This is taking place across all public schools and all government agencies. More recently, the Attorney General of the United States, Merrick Garland, at the request of the National School Board Association, drafted a memo to federal law enforcement officials and prosecutors between themselves and local law enforcement to address threats against local education officials including superintendents, board members, educators and staff by parents and citizens without evidence to substantiate this claim. Local school superintendents and local school boards repeatedly block attempts to introduce K-12 classrooms to unbiased, objective and accurate textbook content and instructional materials related to pornography, Islam, Judaism, Israel, the Arab-Israeli conflict and U.S. history. Americans of various faith traditions, and all people of conscience, are now asking... how can we effectively confront this tsunami of antisemitism, anti-Americanism, silencing of dissent and the destruction of our Judeo-Christian values by America's progressive Marxist elite?







The Solution: Track 1

PJTN has drilled down to the "focus point" of reclaiming education in America: Civics and Holocaust Education in America's classrooms. Our work in Florida in writing educational standards is a beacon of the success that is replicable in all 50 States. Florida Gov. Ron DeSantis' administration has truly set the gold standard for curriculum standards in our nation, and PJTN played a major role in this process.

Our three-year focus will include the three largest purchasers of curriculum: Florida, Texas and California. Our process includes a series of steps that are 'hidden' deep into the decision-making of education curricula standards: PJTN has a new process and new experts on our team to ensure we help every county/state to review, revise and submit recommendations to lawmakers and education decision-makers.

From the statehouse to the local schools and communities, we will follow up, door-to-door if required, to stop antisemitism, anti-Judeo/Christian, Holocaust revisionism and anti-American propaganda from seeping into our children's curricula and becoming normalized for another generation. We are not marching behind placards or breaking down school board doors.



We are behind the scenes building relationships with state legislators, state departments of education and governors and our work will not end with the adoption of Civics and Holocaust standards. Phase 2 of the initiative will require reviewing textbooks, instructional materials, supplemental materials and library books to ensure they follow state standards, are accurate, unbiased and reflect the values of the states, as well as their state and U.S. Constitutions.

This is a comprehensive agenda as the gatekeepers of our children's education and our nation's future.

We will work with local communities to dismantle and overturn "woke" school boards and Marxist-leaning ideologies in our children's classrooms.

PJTN's groundbreaking county-by-county, state-by-state initiatives are not a "one and done!" This will be an ongoing effort until we reach all 50 states.

Thus far, PJTN's successful initiatives have had the potential of impacting more than 20 million K-12 students.

The Solution: Track 2

Principally, we are educating local and state decision-makers as a Judeo-Christian voice demanding that American public schools educate present and future generations about the Holocaust... the horrific and unique genocide of the Jewish people.



Our unique approach touches every student, parent and grandparent simultaneously as PJTN is present in the lives of families who are shocked at the enormity of the task they face. We achieve this by:

- 1. Engaging in grassroots and state meetings and conversations about Civics and Holocaust curriculum.
- 2. Equipping PJTN Watchmen and volunteers with the tools to educate and activate citizens through our original award-winning media available on our PJTN online platform and as well as other multiple media outlets worldwide.
- 3. Working with state legislatures to revise the standards.
- 4. Following, most recently, the adoption of our recommendations for Civics and Holocaust standards in Florida, PJTN was contacted once again by the FL Department of Education to assist them in finding qualified educators and administrators to execute their aggressive agenda to implement Governor DeSantis' new Civics Literacy Education Initiative.



2021 MILESTONES OF SUCCESS

Opening 2021 with the rise of antisemitism in the headlines, the White House under siege, the majority of classrooms empty and the world in COVID chaos, PJTN went forth with a renewed commitment to face the issues of our time - a commitment to provide strategic leadership and moral courage on the frontlines of the issues that confront Christians, Jews and all people of good conscience who are concerned for the future of our country, our children and grandchildren, our Jewish brethren and the Judeo-Christian values that have established and made America great. Our mission was state-by-state:

PJTN VICTORY FOR JUDEO-CHRISTIAN VALUES IN EDUCATION AS REVISED CIVICS AND HOLOCAUST EDUCATION STANDARDS ARE APPROVED IN FLORIDA

Investing two years of research, commitment and considerable time in fighting backlash from opposition, Laurie Cardoza-Moore, Founder and President of Proclaiming Justice to The Nations announced in July 2021 that both Civics and Holocaust Standards submitted by her organization were approved for adoption and use in Florida classrooms. She noted on the vote, "Our work in preserving America's Judeo-Christian heritage and values in our children's Civics education amid the national push towards Critical Race Theory (CRT) will benefit the more than 1.8 million students in Florida classrooms - as will the Holocaust Education materials that will be a national gold standard for Florida."



These newly adopted Holocaust and revised Civics Standards will ensure that our children in Florida know the Judeo-Christian foundations of the birth of this incredible nation. Governor DeSantis sent a message loud and clear, that revisionist history, anti-Semitic content or Holocaust revisionism would not be tolerated in Florida classrooms. PJTN's long term involvement in this success brought a national message to media: "We at PJTN, are humbled and grateful to have been invited to collaborate on this important endeavor for the future of the State of Florida and the United States! Well done Gov. DeSantis!"

AN APPOINTMENT IN TENNESSEE: LAURIE CARDOZA-MOORE CONFIRMED TO SERVE ON TENNESSEE TEXTBOOK & INSTRUCTIONAL MATERIALS QUAILITY COMMISSION.

Tennessee Speaker of the House Cameron Sexton championed Laurie' 2021 election to the influential Committee overseeing the content of textbooks and curriculums being used within Tennessee classrooms. The PJTN values she brings to this Commission will influence the 147 school districts and more than 1,700 public schools within the state. Rabbi Pesach Lerner, president of the Coalition for Jewish Values, the largest Rabbinic Public Policy Organization in America, noted in a



letter of support of Laurie's election to the Commission: "Laurie Cardoza-Moore's concern for children's education goes back years and it is thanks to her efforts that a textbook with minimalized and even justified anti-Semitic terrorism is not being used today to indoctrinate Tennessee children. We believe the children of Tennessee will greatly benefit from her work on the Commission. Laurie noted in accepting the post, "I will vow to help ensure, protect and enrich America's next generation of leadership: Our children. The future leadership of America begins with the quality of materials used in their classroom."

PJTN CALIFORNIA AGENDA: THE BATTLE GOES ON

Since our earliest days of engagement with Governor Gavin Newsom in 2018, PJTN has stood throughout 2021 with hundreds of California and out of state allies, concerned Rabbis, more than 75 religious and civil rights and sister organizations in support of the Jewish community in protesting the progressive passage of the controversial anti-Semitic, pro Critical Race Theory, Ethnic Studies Model Curriculum (ESMC). Launching a national PJTN petition against ESMC, our message was central to a major national press campaign surrounding AB-101 in 2021. Laurie noted, "California is the incubator for liberal educational ideas that go viral across the nation. The vile hatred of antisemitism poses a threat not only to the Jewish students and the Jewish community as a whole, but the next generation of our leadership in America and their future support of Israel."



Going forward, all PJTN hands remain on deck for the California educational agenda! We are actively working to boost the recruitment of more boots on the ground—both PJTN Watchmen, and volunteers, as well as a State Director for the organization to better direct concentrated statewide efforts. The PJTN model worked in February of 2022 with parents rising up to execute the shocking recall of the liberal "woke" school board in San Francisco. As we noted in a PJTN press campaign: "The Dominoes Are Falling!" A "Taking Back America's Children" Summit is being planned in California for 2022.



2021 IN RETROSPECT

This year saw a frightening increase in dangerous textbook and curriculum issues. Proclaiming Justice to The Nations (PJTN) and its textbook and curriculum arm Truth in Textbooks (TNT) worked diligently on many textbooks. It was and is my distinct honor as PJTN's Senior Academic Fellow and as the Director of TNT to work with Laurie Cardoza-Moore on such topics as anti-Americanism, anti-Semitism, Holocaust Revisionism, anti-Israelism, anti-Constitutionalism, anti-American Exceptionalism, the Black Lives Matter Curriculum and the California Ethnic Studies Curriculum. In addition to these, PJTN was requested to examine both the Florida Civics and Holocaust Standards and to draft new Standards in those two disciplines.

What did we "accomplish" this year? We wrote and submitted new K-12 Civics and Holocaust Standards to the Florida State Board of Education (SBOE). The standards are under consideration, and we will know the result during the year. However, what I think is important is that Laurie is now able to open an academic dialogue with other SBOEs on Civics and Holocaust Education, the historical revisionism of the Constitution, the establishment of the Judeo-Christian Tradition by our Founding Fathers, immigration, and citizenship, among other Civics-related topics. Similarly, Laurie will also open a pointed dialogue on how the SBOE and the State fulfill their Governor's mandate to promote the National anti-Semitism ruling in the classroom and to ensure the correct teaching of the Shoah.

The results of these accomplishments, while impressive, reside in the future. Where we have been both active and successful in 2021 is in the review of textbooks with egregious errors that teach Jew-Hatred and are therefore responsible for the continuous increase in anti-Semitism. Where textbooks teach anti-Semitism, they also teach anti-Israelism and the delegitimization of Israel as a Nation-State, while teaching the promotion of the "Palestinian Narrative." TNT reviewed textbooks in use and under consideration in all of the areas listed above. I train volunteers as reviewers to help with the initial work.

PJTN has been invited to participate in the State Textbook Adoption Process of such states as Florida (2021), Texas and Tennessee (2022). It is my duty and honor to review the textbooks up for purchase and to make a careful recommendation on each.

If I were asked to comment on what I consider our most important, (and still ongoing) responsibility, I would respond that, without hesitation, it was our work in bringing forward in 2021 the egregious historical revisionism, anti-Americanism, anti-Semitism, anti-Israelism and Holocaust Revisionism of Pearson Publishers and their role in teaching hatred, bigotry and anarchy. None of what we did in 2021 is finished. Everything is ongoing and urgent. I will face the publishers one on one, as I have done for almost 20 years, and confront them with their egregious errors and Leftist agenda. We will ask for corrections and make the errors public...just as we will do with their responses. 2021 is over but our work is not.

It is at this point that I must add my opinion on the mandate facing us in 2022. We must ensure that Civics Education in this country teaches the Judeo-Christian Heritage of the United States, the dedication of the Founding Fathers to Mosaic Law, the place and contributions of American Jews as American citizens to American society, the dangers of all religious and ethnic bias, and the rights guaranteed by the United States Constitution to all American citizens who accept and adhere to the Rule of Law. To accomplish this mandate, Standards for Civics Education must be reviewed thoroughly and revised to eliminate their anti-Americanism and anti-Semitism and Standards for Holocaust Education must be reviewed and revised to stem the tide of revisionism, to teach the meaning of Jew-Hatred, to protect and reinforce the bond both between Christians and Jews in America and Israel. That is the mandate given to all of us.

How to Remove Critical Race Theory from Our Schools

State legislators know nothing about Critical Race Theory (CRT). Descended from Critical Theory (CT) created by the Marxist German Frankfurt School, CRT is the latest effort to divide Americans by race and create a hierarchy of victimhood to use in the war against America's history and our free-market economy, with the goal of turning the United States into a Marxist state.

Do our state legislators fear CRT as the existential national threat it is? Are they or are they not willing to expunge its divisive concepts from our educational system, and are they willing to stay the course to achieve this end? Reviewing their legislative behavior, apparently they are not.

Although state legislatures have the authority to write effective anti-CRT legislation, the evidence demonstrates that thus far their members do not have the fire in their bellies to make this work. It now becomes the task of America's grass roots to take action to ensure that our elected state legislators and governors enact effective anti-CRT legislation, laws that include the means to eliminate its divisive concepts from our schools.



An ad hoc working group in which I participate has drafted model anti-CRT divisive concepts legislation to educate state legislators on what language must be included in such legislation to make their bills effective. In doing so, we reviewed anti-CRT bills proposed, and laws passed, in several states. Most statutes are extremely weak and are incapable of halting the teaching of CRT divisive concepts in our schools. Why were such ineffective laws adopted? Our presumption was that although the authors of the bills wanted to include stronger language in their legislation, they could not gain enough support for passage from their legislative colleagues, and from governors who would have to sign the bills, without first stripping their bills of language which would realistically enable them to eradicate the indoctrination of our children in CRT divisive concepts in the real world that is our education system today.

We found that our presumption was correct. Members of our working group were included in a conference call among state legislators who had sponsored what turned out to be marginally or totally ineffective anti-CRT bills that became law, and sponsors of bills which had not yet passed committees to be sent to their House and Senate chamber floors for a vote. These sponsors took what they could get passed, but the resultant statutes are insufficient to accomplish the task.

Legislators and governors who support only bills that will not bring the teaching of CRT divisive concepts in our schools to a screeching halt are merely virtue signaling. They want the voters to believe that they are protecting their children and the nation from this noxious, racist curriculum meant to transform America into a collective state which will control the entire economy and strip individual citizens of their individual rights.

Bills which will in fact remove CRT concepts must constitute an impenetrable legal brick wall which will completely block CRT indoctrination of our students. Such laws first must contain language strong enough to block from the schools all types of funding which would support CRT divisive concepts-facilitating programs. Secondly, they also must include penalty provisions sufficiently robust to deter providers of CRT divisive concepts from indoctrinating our children.

Funding - These statutes must block all sources of funding for CRT divisive concepts teaching in our schools. This includes all federal sources and individual states' sources, including prohibition of grants from a state agency to a state or local educational agency. One state's Department of Education is offering grants to local school districts, schools, and teachers to teach the 1619 Project curriculum. All private funding sources must also be blocked.

The statute must clearly make it unlawful for an educational entity, from the state down to the individual teacher, to solicit, accept, or use any such funds for any purpose related to preparing teachers for, planning for, or teaching any of the CRT divisive concepts prohibited by the statute.

Enforcement - Some states have already included language to the effect that a teacher who teaches the divisive concepts prohibited by the legislation is at risk of losing his or her teaching certification. Other states are trying to include language mandating that a student who attends any class in which these concepts are taught will not receive credit toward graduation for completing that class.

However, the most effective deterrent will result from placing the main enforcement of the law not in the realm of bureaucratic action, but in the hands of the parents and guardians of the students who are damaged by the indoctrination they are receiving. There should be in every anti-CRT statute a private right of court action, not just for equitable relief (i.e., a judge ordering the school board to stop teaching the statutorily prohibited divisive concepts because they are violating the law in doing so), but in addition, for money damages (compensatory, consequential, and punitive) judgments in favor of damaged student/parent/guardian plaintiffs against both the state and local boards of education, including their individual members, and against individual teachers who teach these concepts in violation of the statute.

Citizen Action - Influencing your state legislators to pass effective legislation is one more responsibility for our grassroots citizens who vote them into office, especially the parents and grandparents of the children being indoctrinated. Our citizens who are already educated, or who are presently becoming educated, on the seriousness of CRT racism and indoctrination in the schools and the consequence both to the children and to our nation, must engage in this effort. All concerned voters should contact their own state representatives and senators; each member of a state house and senate K-12 and higher education committee; the speaker of the house and the majority leader of the senate, and their governor's office, to express their concern and to demand that effective anti-CRT divisive concepts legislation be drafted and passed into law in their state. Look online for their contact information on your state house and senate and governor's websites. Call them on the phone and leave detailed messages stating your requests. Send them strong but civil emails. Make appointments to meet with them as individuals or groups, either in their offices in the state capital or in their districts. Let them know that you support and will elect legislators who take this matter seriously and who will legislate affirmatively by incorporating clear-cut language to cut off funding from these programs and imposing effective penalties for violations. Let them know that neither you nor your friends and neighbors, who are their constituents, will elect candidates or reelect incumbents who fail to do so.

Our Mandate and Marching Orders ——

- **K-12 Education** We will remain engaged as a thought leader and major agenda-setter in the war against anti-Semitic content in curricula. In the decade since we began our successful initiative in Tennessee (1.3 million students), we are now working with the governors, state departments of education and state legislators in **Florida** (1.8 million students); **Texas** (5 million students); **Ohio** (1.7 million students); **California** (6 million students); **Arizona** (1 million students); **Minnesota** (850,000 students); **Pennsylvania** (140,000 students); **New Mexico** (340,000 students) and **Nebraska** (316,000 students), the next state to adopt our initiative. These states combined account for over 20 million students that we can re-educate in grades K-12 every year. Priority states for PJTN in 2022 will be Florida, California and Texas. These three states constitute the largest purchasers of school textbooks and curricula and thus exert national influence on what materials are ultimately presented in classrooms across the nation. We will be an influencer!

In short: PJTN will be positioned on the frontlines and in the headlines with "Taking Back America's Children" and other agenda in 2022 and beyond.


